**Sub: - Preparation of a panel for selection for the post of Superintendent/Inspector (Legal Affairs) Group 'B' (Gazetted/Non Gazetted) on deputation in the Directorate of Legal Affairs circulated vide earlier reference No. F.No. 1080/57/DLA/PANEL- INSP./2003/ dated 25<sup>th</sup> February, 2009 and F.No.1080/16/DLA/Misc/2006/Pt. dated 29.05.2009-reg.**

The Directorate of Legal Affairs, New Delhi is in the process of drawing a panel of suitable candidates for filling up the vacancies in the grade of Superintendents (two) and Inspectors (two) in the Pay Band-2 + Grade Pay of Rs. 4800/- and 4600/- respectively.

It is proposed to fill up these vacancies by appointing suitable officers on deputation basis in their respective grades. The selected officers, while working in the Directorate will be entitled for a deputation allowance of 10% Basic Pay + Grade Pay in terms of DOP&T OM No.2/22(8)2008-Estt(Pay-II) dated 03.09.2008, subject to the prescribed ceiling of Rs. 4000/- p.m. Normally, the deputation is for a period of three years extendable by another two years, by competent authority subject to the willingness of the officer and the concurrence of his parent Commissionerate.


