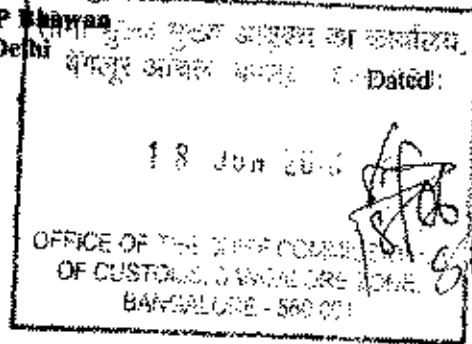

Sub : Preparation of a panel for filling up the post of Technical Officer (T.O.) Group- B (Non-Gazetted) on deputation in the Directorate General of Human Resource Development (Infrastructure & Welfare Division).

It is proposed to draw a panel of suitable and eligible officers for filling up the deputation post of Technical Officer (T.O.) Group 'B'(Non-Gazetted) in the Directorate General of Human Resource Development (Infrastructure & Welfare Division) at New Delhi. The posts are in the pay Band -2 of Rs. 9300-34800/- with grade pay of Rs.4600/-.

2. In accordance with the recruitment rules applicable to the post, the following officials are eligible to be considered for appointment against the deputation post of Technical Officer (T.O.) Group 'B'(Non-Gazetted) in the Directorate General of Human Resource Development (Infrastructure & Welfare Division).

- (i) Inspectors of Central Excise
- (ii) Preventive Officers of Customs and
- (iii) Examiners of Customs

3. The officials selected for posting as Technical Officer (T.O.) Group 'B'(Non-Gazetted) in the Directorate General of Human Resource Development (Infrastructure & Welfare Division) on deputation basis would normally be appointed initially for a period of 3 years. The pay of the selected officers will be regulated in accordance with the ministry of Finance O.M. No.19(2#)E III/60 dated 04.05.1991 as amended from time to time. Presently, the Technical Officers (T.O.) are entitled to Deputation (Duty) Allowance in terms of DOPT's O.M. No.2/22(BY)2008-Estt (Pay-II) dated 03.09.2008.

4. Applications from the interested and eligible officers accompanied by relevant personal data viz. name, date of birth, educational qualification, Computer knowledge if any present post and the date from which it is held, scale of pay, history of previous postings with charges held along with their CCR dossiers may please be forwarded to this Directorate latest by 15<sup>th</sup> July, 2010. It may also please be certified that no vigilance/non-vigilance case is pending or being contemplated against any such officials. Preference will be given to officers who have knowledge of computer Applications. Officers applying for the post may be given to understand clearly that if they apply for the post, they will not be allowed to withdraw their candidature subsequently.
