OFFICE MEMORANDUM

Few post of Preventive Officers are vacant in Kandla Special Economic Zone, Gandhidham, Kutch, Gujarat. The pay scale of Preventive Officer is Rs. 9300-34800 + 4600 and according to the recruitment rules, the posts are required to be filled in by deputation from the Customs and Central Excise Department holding analogous posts on regular basis & possessing two years experience in Customs or Central Excise procedural work .

The terms of deputation of the Preventive Officers will be regulated in accordance with the instructions contained in Ministry of Finance O.M.No. 02/29/91/ESTT(Pay II) dated 5-1-1994 as amended from time to time, to draw pay of the post held by them in the parent department plus deputation allowance in accordance with and subject to the conditions laid down in the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training O.M.No. 2/8/97-Estt(Pay II) dated 11-3-1998 & No.2/22/B/Estt/Pay 11/dated 3-9-2008 as modified time to time and such other general or special orders issued by the Ministry of Finance.

The officers selected will be entitled to Transfer T.A. and joining time in accordance with the rules of the Government of India in force.

It is requested that the names of eligible and willing officers may be recommended alongwith 1) ACR gradings & photo copies of ACRs for last five (5) years duly attested 2) Vigilance clearance certificate 3) Integrity certificate 4) details of penalties, if any imposed during last 10 years & any proceedings pending or contemplated for selection as Preventive Officer on deputation basis. In absence of these requirements application will not be processed. The last date of receipt of names of suitable officers is 60 days from the date of issue of this circular. Advance copies of applications will not be entertained .
