A post of Assistant in the Pay Band of Rs.9300-34800 with Grade Pay of Rs. 4200/- is to be filled up in the Office of the Competent Authority, SAFEMA/NDPSA at Mumbai. The post is to be filled up on deputation basis from amongst the eligible and willing officers of Central Government or State Government organizations.

**Eligibility :**

Officers of the Central or State Government Departments or organizations.

- (i) Holding analogous post; or
- (ii) Upper Division Clerk of the Central or State Government Departments or Organisation of Income-tax or Central Excise or Customs Commissionerates or Directorates of Narcotics in the pay scale of Rs.4000-100-6000 (scale prior to 6<sup>th</sup> Pay Commission) with 8 years service in the grade.

However, in the absence of candidates with sufficient service, i.e. 8 years, officials with lesser service will be considered.

The normal deputation period will be 3 years. The selected candidate will have the option to draw the existing pay with deputation allowance or pay in the new pay scale, if selected to a higher post.

Bio-data of the eligible and willing officers may be called for and forwarded to this office alongwith vigilance clearance and ACR gradings for the last five years / the last actual years such officers have worked so as to reach this office by 14.09.2010.
