
3. The deputation period shall be for a period of five years. The officer selected will be entitled to draw special pay equivalent to 10% of the basic pay subject to a ceiling of Rs.800/- per month.

It may please be made clear to the officers that option once exercised would be final and in the event of selection to this Directorate General, they will not be allowed to withdraw the same. **While recommending the names, it may please be indicated whether any vigilance / non-vigilance case is pending/contemplated against such officers. The ACR gradings of willing officers for the last five years may also be forwarded to this office for evaluation.**
