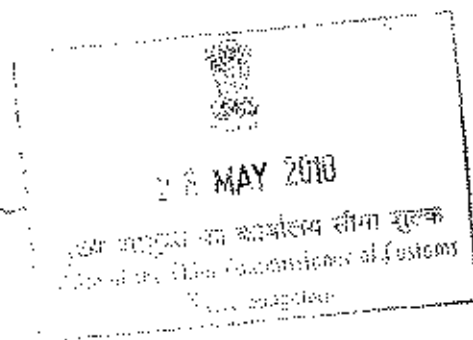

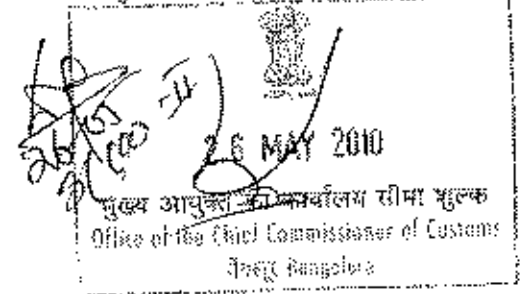

Subject: Panel of Customs Officers for selection to the post of Appraiser of Customs, CSEZ, Cochin - regarding.

It is proposed to fill up one post of Appraiser in the Office of the Development Commissioner, Cochin Special Economic Zone, Kakkanad, Cochin - 682 037.

As per Recruitment Rules, the post is to be filled up on deputation basis. Period of deputation including period of deputation in another ex cadre post held immediately preceding this appointment in the same or some other organization or department shall ordinarily not exceed 3 years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications. As per Recruitment Rules, the post of Appraiser of Customs is to be filled up from

Officers of the Central Board of Excise & Customs;

- (a) (i) Holding analogous posts on regular basis in the parent cadre of department; or
- (ii) with 3 years service in the grade rendered after appointment thereto on regular basis in the Pay Scale of Rs.7500-12000/- (pre-revised) or equivalent in the parent cadre or department; and
- (b) possessing 2 years experience in Excise or Customs procedural work.

You are requested to send a panel of names of willing and interested officials along with bio data, attested copies of annual confidential reports for the last 5 years, and clearance certificate from the vigilance angle to fill up these posts. Deputation will be for a period of 3 years and officers who can be spared may be included in the panel. The post is required to be filled up immediately and terms and conditions will be governed by the Government of India instructions issued from time to time.
